Dear Members,

Have you implemented Workplace Safety & Health (WSH) Regulations at your Company?

The WSH Act was passed on 1st March 2006 and has taken effect on 1st September 2006. MOM has given companies 6 months to comply with this mandatory act. According to the Act, employers, self-employed personnel or principals (including contractors & sub-contractors) who fail to conduct risk assessment and take appropriate actions to eliminate or reduce associated risks will be subjected to a penalty.

First time offenders can be fined up to S\$1,000. For second or subsequent offence, the offender can be fined up S\$20,000 or jailed up to 6 months or both.

To assist Small and Medium Enterprises (SMEs) implement risk management, MOM set aside a \$5 million Risk Management Assistance Fund (RMAF) to help SMEs defray the cost of engaging consultants to conduct risk assessments and to build in-house capability.

To aid SFMA members with WSH Act compliance, we have invited MOM speakers, Mr Tan Fang Qun and Mr Teo Boon Kwong to present on the WSH and RMAF on **19 September 2006, Tuesday at 4pm** in SFMA Conference Rm (Level 2). We would like to invite a representative from your company to attend this seminar to learn how to conform to this new WSH Act.

亲爱的会员：

您的公司是否已执行<工场安全与卫生法(风险管理条例)>?该法令已于2006年3月1日生效,取代原有的工厂法令,并从9月1日起正式实行.当局已给予业者半年的时间,为这项新要求作好准备.根据新法令,雇主和业者必须在工作场所推行风险管理,否则可能被罚款.

违反条例的公司可罚款不超过1000元,重犯者则可被罚款高达2万元或监禁不超过6个月,或两者兼施.

为协助中小型企业改善工作场所安全水平,政府拨款500万元设立风险管理援助金,津贴聘请安全顾问进行风险评估和改善工作场所安全的费用.

鉴于该条例已于9月1日正式实行及为免会员触犯法令,本会特别邀请人力部工场政策与策略署官员及合格风险评估顾问于19/9/06(星期二)下午4时正在本会会议厅举行一个说明会,希望会员公司负责人或代表,尽可能拨出时间出席.请填写所附上的回条,于15/9/06前传真62237235至本会秘书处.
